Report for Task Force on Emerging Issues  
Meeting of New Hope Presbytery  
July 19, 2005

Some months ago, our Presbytery Executive issued a general invitation for persons who would like to serve on a "Task Force on Issues that Matter".

That's a fairly provocative title... issues that matter ...and so I responded, thinking I was joining a task force to discuss ACC basketball or the recent American Idol competition.

But, alas, this task force was being assembled to discuss other things...and, more than that, this task force was being assembled to help New Hope Presbytery carry on meaningful dialogue about matters of theological and ecclesiastical consequence.

Specifically, this voluntary task force was assembled to help the churches within the Presbytery and the Presbytery itself navigate some potentially turbulent and divisive waters, and to do so while continuing to maintain a unity of the spirit in the bond of peace (Ephesians 4:3).

When we gathered for the first time in mid-May we spent some time getting to know one another, and in a moment of inspiration, we elected Jim McKinnon as our moderator. And with regard to the reason we were gathered together in the first place, as a starting point, we are asked to consider three general topics.

a. Presbyterian/Jewish relations, in light of the recent General Assembly actions regarding a congregation in Philadelphia that had a particular ministry of outreach to the Jewish community and the decision to *"initiate a process of phased, selective divestment in multinational corporations operating in Israel, in accordance with General Assembly policy on social investing."*

b. The impending report of the *Task Force on Peace, Purity and Unity*, which is scheduled to be issued in just a few weeks. As

you may know, they have been wrestling for years with matters of Scriptural authority and human sexuality. Unless the task force is able to issue a report that pleases everyone, it will be important for PresbYterians to speak honestly and lovingly about matters over which they might disagree, and so our group will consider how we might help facilitate that sort of healthy conversation.

c. Belhar Confession. If you have heard of the Belhar Confession, then you are a step ahead of where I was until I attended the first gathering of this committee. The Belhar Confession traces its history of the church's struggle against apartheid in South Africa. It is now one of the central documents of the new Uniting Reformed Church of Southern Africa. It deals with matters of unity and reconciliation and God's justice for the oppressed. It is being studied by Reformed bodies around the world, and was commended by the General Assembly for study in our churches, as a resource to help us reflect on the insidious nature of racism and its effect on the human community.

So, those were the initial matters before us ...matters of how Christians and Jews are to relate to one another, matters of Biblical authority and human sexuality and matters of racism and how to be God's people where such racism still is an affront to God's justice. And that was just the first meeting! Our plate is full.

This is one of those areas where its difficult to know where to begin. And so we decided our first step was to make sure we could talk openly and candidly and lovingly with each other, and so at a meeting in early June, we came together for Bible study, using a model for study that invites full participation by everyone at the table, a model that lends itself not to debate, but mutual upbuilding. Not everyone saw the same things in the text that was before us, but we listened to one another and we grew as a community. .

This is our vision for us as a Presbytery, and while we are not ready with a prescription for how this will be accomplished, we wanted you to know that

we are at work, and it will be our intention to use any mechanisms currently at work in the PresbYtery, such as regional cluster groups, to foster these conversations, or, if a mechanism is not in place in particular areas, we'll be looking for folks who understand the importance of candid, faithful dialogue in a community of mutual forbearance and love.

And actually, one concern I have is whether our task force is truly representative of our PresbYtery. Remember, we simply responded voluntarily to an invitation .. we were not handpicked because we were conservative or liberal or had any particular expertise in these areas. And so if you are interested in joining us, I assume there are still seats at the table

Some PresbYteries are ahead of us on this. Debbie Kirk, from Hudson Memorial in Raleigh, has come here from the PresbYtery of the James, where these dialogues have been going on for some time. But we are committed to helping our churches and our PresbYtery stay connected to one another as we move through these potentially choppy waters.

My personal goal is that we learn from the Task Force on Peace, Purity and Unity. Though they are an intentionally diverse group...they have come to love and respect each other, valuing the faith commitments they see in each other. And while they may differ on matters of great significance, they have come to see that they are united on matters of eternal significance...that Jesus Christ is Lord.
