Report of Council

Reverend Ed McLeod, Moderator
The Presbytery approved the following:

1. That The Presbytery of New Hope support the City of Rocky Mount "Be a Fan" supporting the Special Olympics with a donation of \$250.00
2. That the Presbytery of New Hope have two locations: one being in the Raleigh area and one being in the Greenville area.
3. That the session of Mt. Pisgah Presbyterian Church, Rocky Mount receive \$2,500 in funds to assist with their costs to demolish their manse.
4. That Reverend Gun Ho Lee receive \$3,000 for his sabbatical.
5. Reverend Sam Stone serve on the Nominating committee class of 2011 and

Reverend Ed Stock serve on the Committee on Representation class of 2011.

6. Reverend David Keck was approved to distribute a survey to ministers within the presbytery.
